Membership shall remain in effect (and membership contribution shall be due) until further notice in writing to R.I.S.C. Takers F.C. Termination of membership is effective from the end of a calendar month and is subject to at least twenty-one days notice. In the event of suspension (see *Rules and Responsibilities for Players*) or early termination of the membership, you are not entitled to any refund of paid and/or due membership contribution.
